Citizen of the Socialist Republic of Vietnam is a person holding Vietnamese citizenship (Clause 1, Article 17 of the Constitution).

2. Voting age and age of candidacy

- Citizens shall, upon reaching the age of eighteen, have the right to vote;
- Citizens shall, upon reaching the age of twenty-one, have the right to stand for election to the National Assembly and the People's Councils.

(Article 27 of the Constitution)

4. What is an elected body?

An elected body is an organ directly elected by the people and assigned to hold state power.

In Vietnam, people-elected bodies include: the National Assembly and the People's Council at all levels:

- The National Assembly is the highest representative body of the People and the highest body of State power of the Socialist Republic of Vietnam.
- The People's Council is the local body of State power; it represents the will, aspirations and mastery of the local People; it is elected by the local People and is accountable to them and to the superior State bodies.

5. Who is a people-elected deputy?

- Elected deputies are people trusted by voters through elections to decide on their behalf national and local issues.
- Being elected by the People in their constituency;
- Representing the will and aspiration of the people of the whole country or in the locality;
- Consists of:
- * People's Council deputies at all levels (province/district/commune);
- * National Assembly deputies.

6. What are the differences between deputies working on a full-time and part-time basis?

Elected deputies working on a full-time basis: only perform the duties of elected representatives, do not hold any other positions in the state administrative apparatus, adjudication agencies, supervisory agencies, socio-economic organizations and people's armed forces. All working time must be devoted to the activities of the National Assembly.

Elected deputies working on a part-time basis: may spare at least one-third of their working time to perform the tasks of deputies.
